This permanent committee was created by Association of American Pesticide Control Officials (AAPCO) when FIFRA was amended to provide States with Primacy for FIFRA Implementation, Use, and Enforcement (1978).

- SFIREG is composed of Representatives from each of the EPA regions.
- The 10 Regional Representatives form Full SFIREG.
- **Research and** The SFIREG Representative is responsible for communicating with the states in the region and bringing regional issues to Full SFIREG.
 - All States and Territories are represented at Full SFIREG through their Regional Representatives.
 - Pre-SFIREG Meetings held in the Regions provide the opportunity for State, Territories, and Tribes to discuss issues which are communicated to Full SFIREG by their Representative.

SFIREG'S ROLE

SFIREG provides a means for the States to communicate directly to EPA and enables States to play a meaningful role in the development of pesticide policies and regulations.

SFIREG is where the States/Territories can bring issues to the table to discuss with one another. If an issue is then considered to have widespread significance and EPA's assistance is needed to resolve the issue, SFIREG develops possible solutions and asks to either discuss the issue further or seeks resolution from EPA.

Presenting Issues to Full SFIREG

White Paper

Informs Full SFIREG about a complex issue;

Presents Regions thoughts on the matter;

Meant to assist Full SFIREG to understand an issue, solve a problem, or make a decision;

Full SFIREG will determine action.

Issue Paper

Document significant issues of national concern;

Require action on the part of EPA to resolve concerns;

Specific, agreed upon format and process:

Requires response from EPA

Full SFIREG will determine action.

Full SFIREG – Issue Topics & Actions

- Identify as national issue and forward to EPA
- Determine issue and solutions
- Research and input from SFIREG members and JWC
- Return to SFIREG regional member and JWC for additional refinement
- If the topic is significant, then it becomes an issue paper with suggested actions and timelines for communicating to EPA

 - Treated Articles, Treated Seeds (2020-2022)
 - Managed Pollinator (2020-2021)
 - Pesticide Devices in Health Care Facilities (2019 to 2020)

Full SFIREG and Joint Working Committee Recent Items of Interest

- Dicamba registrations and regulation,
- 24(c) and 25(a) EPA and state registration processes,
- COVID-19 EPA response and registrations, disinfectants,
- Regulation of Devices, products such as disinfectants, making health claims,
- PFAS/PFOS in containers, pesticide products, environment, human health,
- Pollinators and managed pollinator use of pesticides,
- Pesticide herbicides, composted material, EPA assessing Ecological Risks Posed by four Pyridines and Pyrimidines herbicides, PID for picloram and interim decisions for clopyralid, dithiopyr and triclopyr,

- Cancelation of Food and Feed uses of Chlorpyrifos,
- New EPA notice for comments, Petition to Ban all OPs,

Full SFIREG and Joint Working Committee Recent Items of Interest

- Reregistration review of pesticides, EPA 15 year schedule, PIDs, Final IDs,
- Atrazine mitigation measures, watersheds,
- Biological Evaluations (BEs), and Biological Opinions (BiOps), EPA, NOAA Fisheries,
 - NOAA BiOps for Chlorpyrifos, Diazinon, and Malathion came out in 2017,
 - EPA BEs & BiOps for Atrazine, Simazine, Propazine, Carbaryl, Methomyl, Glyphosate,
 - EPA assesses Risk for National Level Listed Species while conducing Biological Evaluations of Conventional Pesticides,
 - New EPA Pesticide ESA Workplan and Pilot Projects. Refer to the EPA ESA page and plan https://www.epa.gov/endangered-species/epas-workplan-and-progress-toward-better-protections-endangered-species

- EPA expects to approve amended labels and develop Endangered Species Protection Bulletins for Bulletins Live! Two, 18 months after final BiOp issuance or other regulatory decision,
- Agreed-upon mitigation measures are intended to reduce runoff and spray drift from treated areas,
- Once these measures are incorporated into product labels, pesticide users must follow them,
- Mitigation measures can include check lists and scoring systems on labels,
- Measures that are only applicable near a species habitat will be implemented via Bulletins Live! Two, an online system that describes geographically specific pesticide use limitations to protect listed species and their designated critical habitats,
- Link to Bulletins Live! Two will be on the product labels,
- Considerable amount of new training would be needed.
